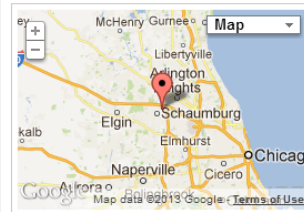
In addition to real estate law, the attorneys of Gardi and Haught Ltd. also practice corporate law, family law, estate planning, personal injury law and immigration law.
